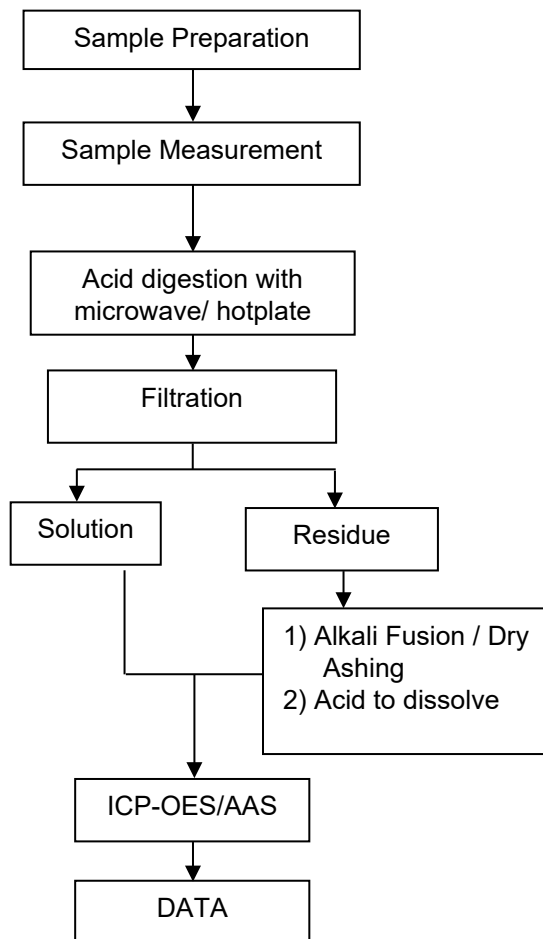

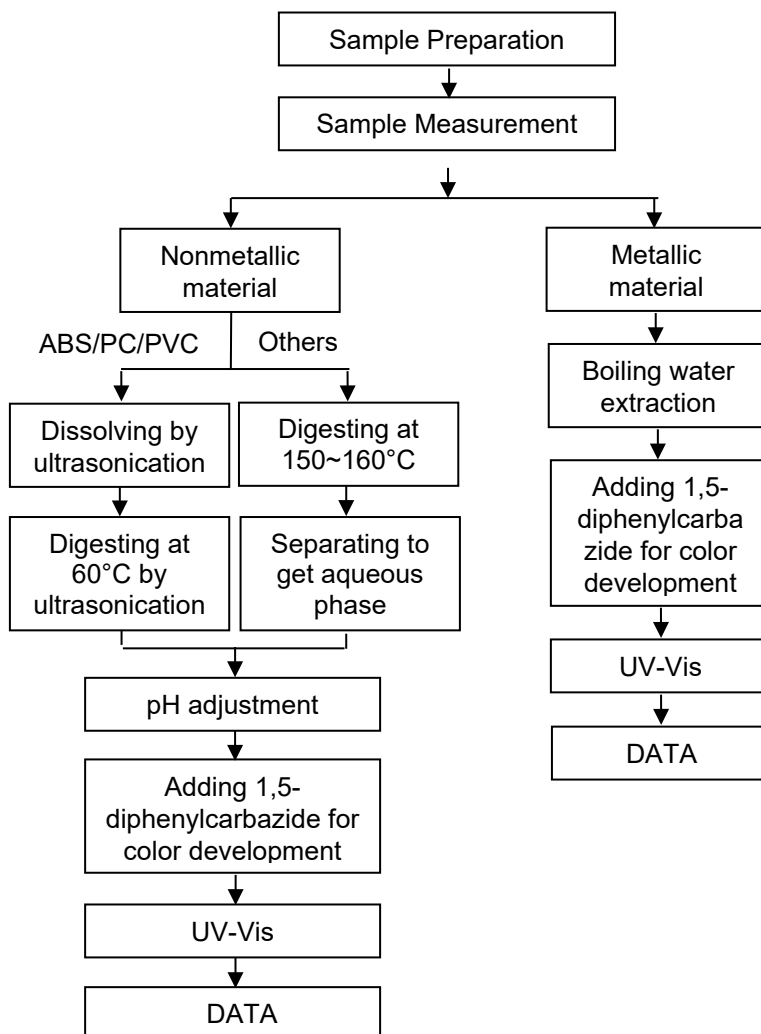

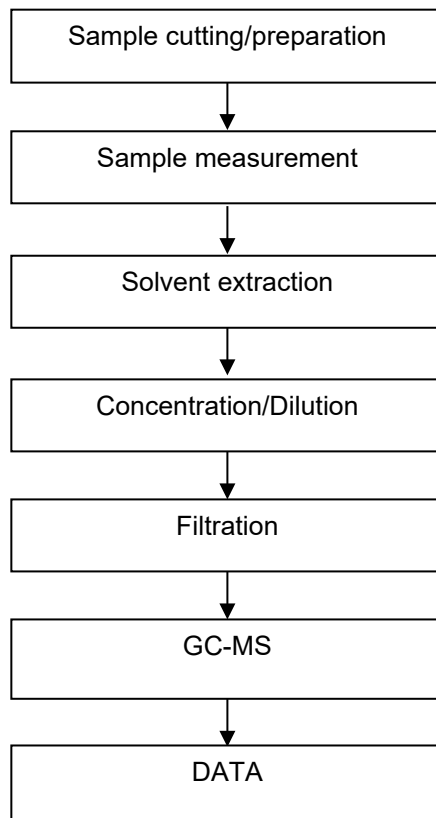

PBB(s)/PBDE(s)/Phthalates Testing Flow Chart



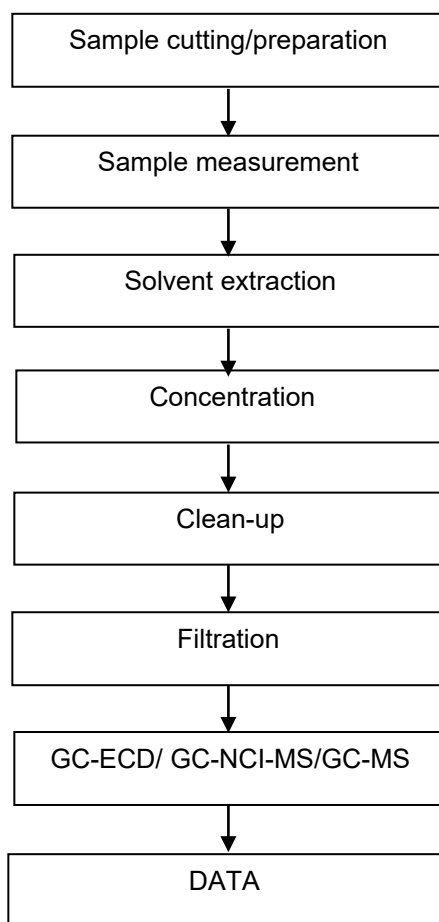

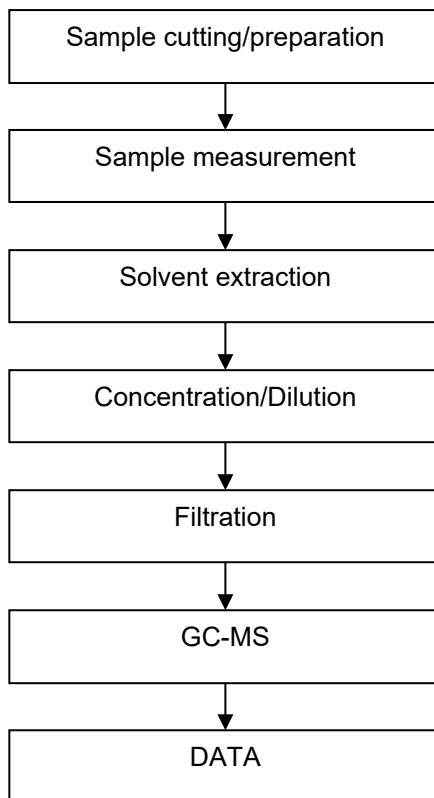

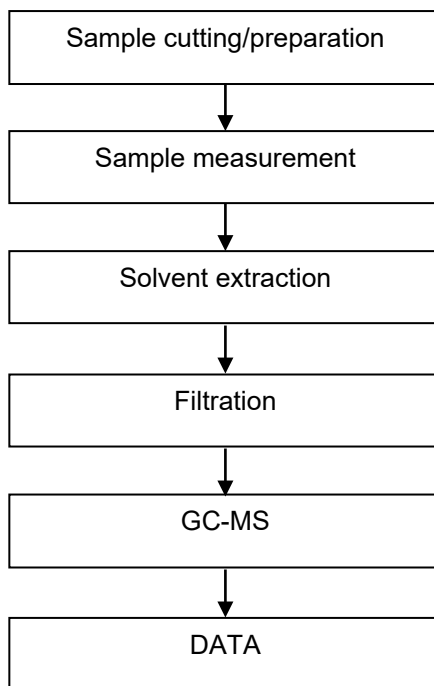

Persistent, Bioaccumulative, and Toxic (PBT) Chemicals Testing Flow Chart



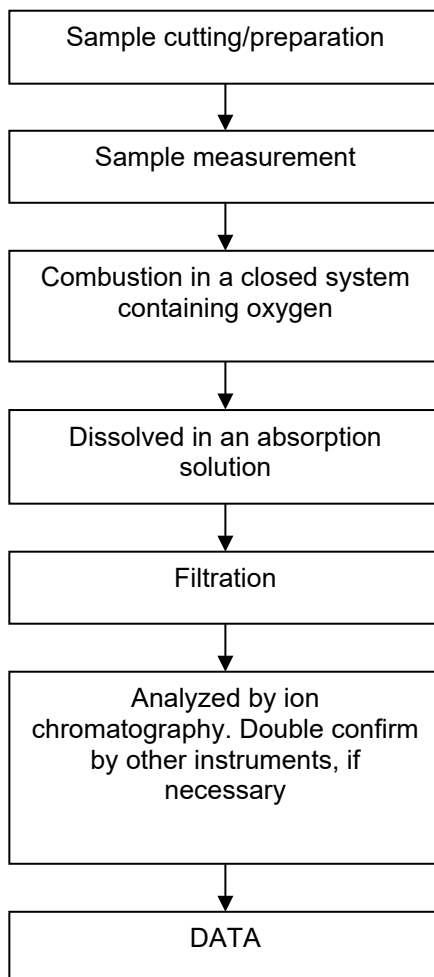

Halogen Testing Flow Chart



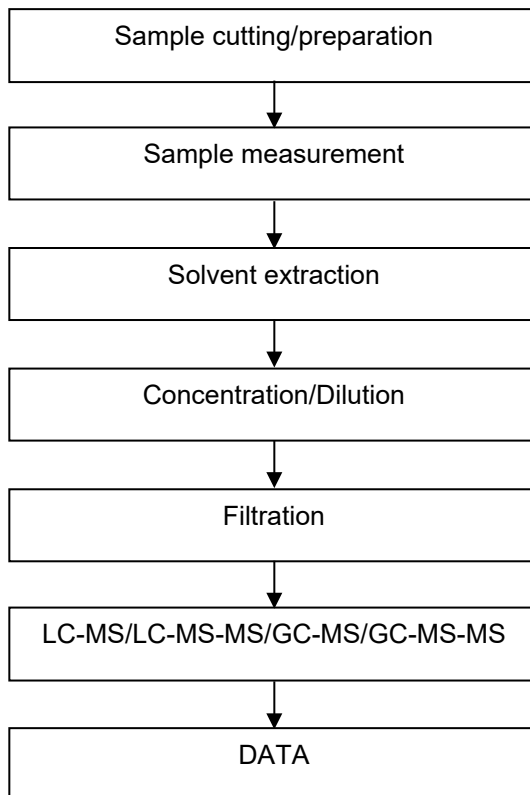

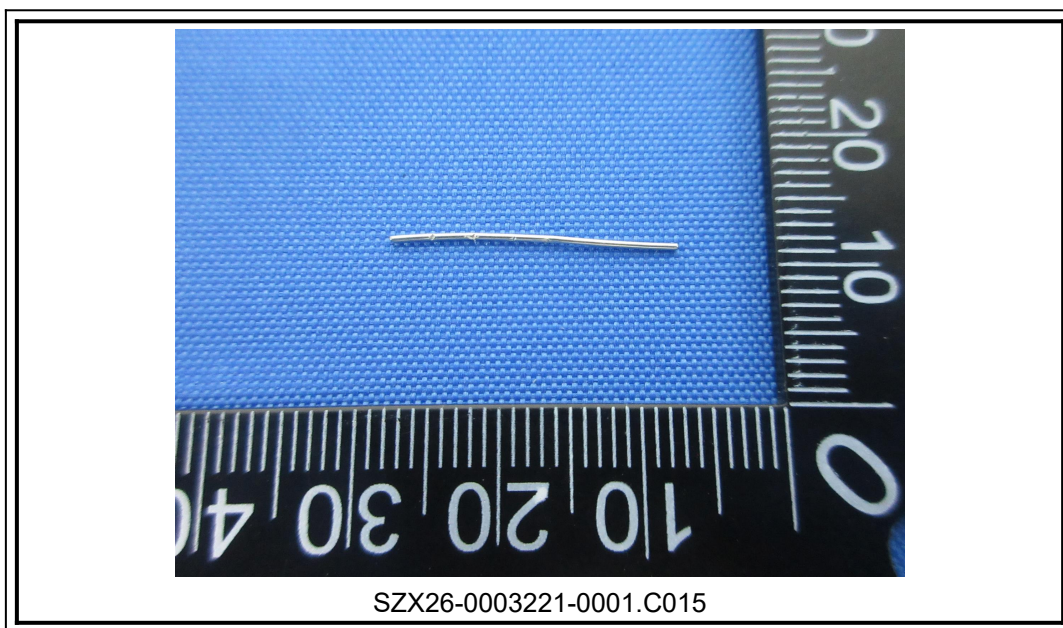
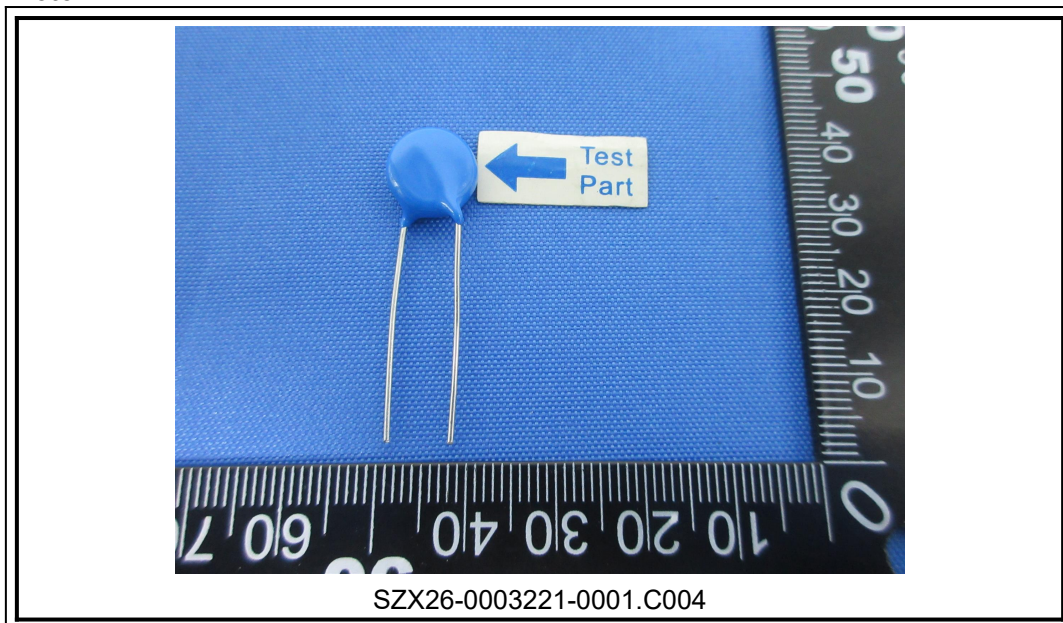
